Enbridge Gas Home Efficiency Rebate Program

(Begins July 15, 2024)

- > Complete a minimum of 2 upgrades
- > Primary and non-Primary residences qualify
- > Final Audit must be completed within 120 days of first audit
- > Maximum rebate of \$5000 (including up to \$600 for audit fee)
- > Home must be heated by Enbridge natural gas at Pre or Post audit

Examples of Rebate Combination Options:

- A) Cold Climate Heat Pump + Attic Insulation = up to \$2,500 rebate with a 2 Ton unit (up to \$3,500 with a 4 Ton unit)
- B) Attic Insulation + Basement/Header Insulation = up to \$3,300
- C) Attic Insulation + Basement/Header Insulation + Air Sealing = up to \$3,480

Note: Audit reimbursement of \$600 would be in addition to the amounts listed above

Air Source Heat Pumps:

Central Ducted <u>or</u> Ductless Air Source Heat Pump <i>Note: Must be listed on NRCan's approved eligibility list. Rental heat pumps qualify. Heat does not have to be distributed to entire home.</i>	≥ 1 Ton to < 1.5 Ton	3.52 kW (12,000 Btu/h)	\$500	\$250
	≥ 1.5 Ton to < 2 Ton	5.28 kW (18,000 Btu/h)	\$750	\$375
	≥ 2 Ton to < 2.5 Ton	7.03 kW (24,000 Btu/h)	\$1,000	\$500
	≥ 2.5 Ton to < 3 Ton	8.79 kW (30,000 Btu/h)	\$1,250	\$625
	≥ 3 Ton to < 3.5 Ton	10.55 kW (36,000 Btu/h)	\$1,500	\$750
	≥ 3.5 Ton to < 4 Ton	12.31 kW (42,000 Btu/h)	\$1,750	\$875
	≥ 4 Ton	14.07 kW (48,000 Btu/h)	\$2,000	\$1,000

Attic Insulation:

Prorated based on 20% minimum roof assembly insulated
Rebate for any combination of attic, cathedral ceiling and flat roof insulation cannot exceed \$1500

Level of Insulation at the time of Pre-Audit	Minimum Insulation Level Required	Maximum Rebate (if 100% is completed)
Less than or equal to R-12	R-50	\$1,500
Greater than R-12 to R-25	R-50	\$1,200
Greater than R-25 to R-35	R-50	\$900

Cathedral Ceiling/Flat Roof Insulation:

Prorated based on 20% minimum roof assembly insulated
Rebate for any combination of attic, cathedral ceiling and flat roof insulation cannot exceed \$1500

Level of Insulation at the time of Pre-Audit	Minimum Insulation Level Required	Maximum Rebate (if 100% is completed)
Less than or equal to R-12	R-20	\$780
Less than or equal to R-25	R-28	\$780

Basement Insulation:

Insulate a min. 20% of basement walls, min. 80% of entire foundation header area, and/or min. 50% of basement slab area
If insulating basement and crawl space walls, maximum amount is capped at \$1,500 for both
(Note: Wall + Header = 1 measure. Basement slab counts as a separate measure.)

Insulation Added Between Pre/Post Audit	Maximum Rebate (if 100% is completed)
Wall: R-10 to R-22	\$900
Wall: Greater than R-22	\$1,500
Slab: At least 50% of your entire basement slab by a minimum of R-3.5	\$500
Header: At least 80% of your entire foundation header to increase insulation value to add a minimum of R-20	\$300

Note: Foundation header can be a basement header, a crawl space header, or a combination of these two

Crawl Space Insulation:

Insulate a minimum of 20% of crawl space walls or ceiling, and/or minimum of 80% of entire header area
 If insulating basement and crawl space walls, maximum amount is capped at \$1,500 for both
 (Note: Wall + Header = 1 measure. Crawl space ceiling counts as a separate measure.)

Insulation Added Between Pre/Post Audit	Rebate Amount (if 100% is completed)
Wall: R-10 to R-22	\$600
Wall: Greater than R-22	\$1,200
Ceiling: Greater than R-24	\$1,200
Header: At least 80% of your entire foundation header to increase insulation value to add a minimum of R-20 Note: Foundation header can be a basement header, a crawl space header, or a combination of these two	\$300

Exterior Wall Insulation:

Prorated based on minimum 20% completed

Insulation Added Between Pre/Post Audit	Maximum Rebate (if 100% is completed)
R-7.5 to R-12	\$1,200
Greater than R-12 to R-20	\$2,100
Greater than R-20	\$3,600

Exposed Floor Insulation (minimum 120 sqft):

Can include overhangs or floors above unheated spaces such as a garage

Insulation Added Between Pre/Post Audit	Rebate Amount
Minimum of R-20	\$300

Air Sealing:

Option	Rebate Amount
Achieve Base Target on the Renovation Upgrade Report	\$120
Achieve 10%+ above the Base Target on the Renovation Upgrade Report	\$180

Windows, Doors and Skylights:

Criteria	Rebate Amount
Each window, door or skylight replaced with an ENERGY STAR certified model (Minimum of 3 windows, or 1 door or 1 sliding door or 1 skylight replaced with ENERGY STAR certified models required to count as (1) measure)	\$50 per rough opening

Heat Pump Water Heaters / Ground Source Heat Pumps:

Rental equipment is eligible

Option	Rebate Amount
Replace your natural gas domestic water heater with an ENERGY STAR certified Domestic Heat Pump Water Heater (HPWH)	\$500
Install a ground source heat pump - <u>pump only</u> with one that meets Canada's Energy Efficiency Regulations	\$1,500
Install a ground source heat pump - <u>full system</u> that meets Canada's Energy Efficiency Regulations	\$3,000
